

# Michigan Chamber Releases Legislative Voting Record, Announces Earned Endorsements for State House and Michigan Senate

LANSING, Mich., July 16, 2014 [/PRNewswire-USNewswire/](#) -- The Michigan Chamber of Commerce today released its *2013-2014 Legislative Voting Record - A Competitiveness Scorecard for Michigan*. The purpose of this document is to provide the business community and other interested parties with a measure of how current members of the Michigan Legislature voted on a wide range of key economic issues.

The *2013-2014 Legislative Voting Record* includes roll call votes on important business climate issues such as: campaign finance, environment, human resources, legal reform, tax policy, and transportation investment. The voting record includes 13 roll call votes in the State House and 16 roll call votes in the Michigan Senate.

"The Michigan Chamber is member-driven and policy-focused in our approach to business advocacy," said Michigan Chamber President & CEO Rich Studley. "This voting record documents state legislators voted on legislative priorities developed by Chamber members and approved by the Chamber's 84-member Board of Directors in January 2013."

"We are very pleased to report that 84 House and Senate lawmakers consistently cast their votes in support of jobs and the economy," added Studley. "Forty-four of these lawmakers went the extra mile to earn a perfect 100 percent score on the Chamber's *2013-2014 Voting Record* and they will receive special designation as a 'Champion of Free Enterprise.'"

"All of the incumbents receiving earned endorsements have demonstrated a strong commitment to Michigan's economic competitiveness and free enterprise by supporting policies based on individual freedom, incentive and opportunity," noted Jim Holcomb, Senior Vice President for Business Advocacy & General Counsel for the Michigan Chamber. "Returning these individuals to Lansing will help keep Michigan on the right track through their support of a legislative agenda rooted in job creation and taxpayer protection initiatives."

"Although the 2013-2014 legislative session resulted in many positive outcomes for Michigan jobs providers and taxpayers, more work remains to be done," Studley said. "The Michigan Chamber will remain vigilant in aggressively advocating for increased transportation investment and common sense policies that will improve our state's economic competitiveness and help job providers to create more jobs."

The Michigan Chamber's *2013-2014 Legislative Voting Record* serves as the basis for campaign endorsements for incumbent legislators. Any incumbent legislator seeking re-election to the same office who scores 75 percent or better on the Chamber's *Competitiveness Scorecard* receives an earned endorsement.
