"We urge citizens to protect Michigan's energy future and, if asked to sign a petition to ban fracking, 'Decline To Sign'," Holcomb added.

To assist with managing the grassroots voter education campaign, the Michigan Chamber has retained noted political strategist Stu Sandler, founder of the Michigan-based consulting firm Decider Strategies, who is a veteran of several statewide campaigns.

"Stu has an established track record of being aggressive and winning statewide fights against senseless proposals," said Studley. "In 2012, Stu was a key consultant to the Michigan Chamber in opposing five damaging proposed constitutional amendments – all of which were defeated."

Last month, environmental extremists announced the kickoff to a statewide effort to collect signatures for an initiative to ban fracking in Michigan, despite decades of safe, reliable energy exploration.

"The Michigan Chamber is committed to protecting Michigan's Energy Future and we will aggressively fight all attempts by extremists who would raise home heating bills and cut jobs," said Holcomb.

Two years ago, environmental extremists failed to collect enough signatures to put an initiative on the 2014 ballot.
