Inspired by Attorney General Cox, Hantler joined his gubernatorial campaign in 2010, performing a variety of tasks – from voter contact to event coordination. In the summer of 2010, Hantler joined the staff of the Republican Governors Association in Washington D.C., carrying out candidate research on 18 of the 37 gubernatorial races.

As a former candidate for State Representative, Hantler is well versed in both policy and politics. During the 2012 election cycle, Brad utilized his extensive experience serving as a senior grassroots coordinator for Citizens Protecting Michigan's Constitution, the broad-based statewide coalition that led the successful fight to defeat five job-killing constitutional amendments.

"Brad's passion and experience makes him an excellent choice to work with Chamber members at the local level to give job providers across the state a stronger voice in policy debates," said Jim Holcomb, Michigan Chamber Senior Vice President of Business Advocacy & General Counsel.

Hantler holds a bachelor's degree in Political Science from Oberlin College.
